Hamilton Board of Alderman Meeting December 8, 2021 City Hall Meeting Room

The public meeting was called to order by Mayor Keith Gilbert on December 8, 2021. Alderman Fast, Alderman Singer, Alderman Alexander answered roll call. City Attorney Blair Merrigan, City Administrator John Nab, and City Clerk Crystal Dorrel were also present. Meeting was also available via zoom.

Alderman Singer made a motion to approve the agenda. Alderman Alexander seconded the motion. Vote: Fast-aye, Singer-aye, Alexander-aye.

Alderman Fast made a motion to approve Cole Crawford as East Alderman.

Alderman Alexander seconded the motion. Vote: Singer-aye, Fast-aye, Alexander-aye.

Alderman Fast made a motion to Review and Approve bills as presented.

a. Presentation by Jeff Arp, MIRMA - Jeff Arp presented Chief April Melte with a grant for Dash Camera's in the amount of \$3,663.75.

Street Improvement Project- Lindsey Chaffin, Great River Engineering- Doc. 2
Lindsey Chaffin spoke with the Board about different alternatives for the Ardinger Street Project. After much discussion Alderman Fast made a motion to approve an agreement between the City and Consultant for Professional Services for the Reconstruction of Ardinger Street from Samuel Street to Memorial Drive & Memorial Drive from Ardinger to Hwy 13. Alderman Alexander seconded the motion. Vote: Singer-aye, Fast-aye, Alexander-aye, Crawford-aye.

Water Distribution Project- Cary Sayre, Allstate Consultants- Cary Sayre spoke with council about the Water Distribution Project and how it has been a tremendous help with water loss. He explained the water plant has decreased the time it is running from about 12 hours a day to running 4 hours a day. Mr. Sayre also informed council of a challenge the contractor is having with there still being a leak on one of the old lines. They will continue to work on finding it.

Emergency Drought Connection Project- Cary Sayre, Allstate Consultants- Cary explained to council the the contractors were currently working on the emergency drought connection and will continue until the project is done. He will continue to update accordingly.
